## **PART I: THE AUTHORIZED VACCINES (PAGE 13)**

### **1. Are mRNA Vaccines Dangerous? (page 15)**

This chapter explores concerns about mRNA vaccines, including their rapid commercialization and unfinished clinical trials. It highlights the steady increase in adverse side effects since December 2020, including serious effects and deaths.

The chapter sheds light on the silence and sometimes lies of political, administrative, and scientific officials in the face of these facts. It also questions the effectiveness and safety of mRNA vaccines, based on explanations from Dr. Jean-Marc Sabatier, research director at CNRS.
